#### **BIDDING AND BUYING:**

Buyers can participate in the Junior Fair Auctions through one or more of the following:

- 1. Art & Baker's Auction
- 2. Sale of Champions & Jr. Fair Auction
- 3. Online Sale (replaces Multiple Buyer Forms of the past)

Buyers may submit a buyer bid sheet to the Sales Office until Friday, August 5, 2022 – 6 p.m.

Buyer Registration for **New Buyers** will begin Online June 24, 2022 – www.ccjrfairsales.com

### **Premium Bidding (Live Auction)**

All lots will sell by premium bid to the highest bidder. Auctioneers and ring persons will take your bids. Every bid helps the momentum of the sale and the ultimate price a 4-H or FFA member receives for his or her auction project. When the auctioneer cries "SOLD", the person with the highest bid is the purchaser. Auctioneers will settle any bid disputes and have the final decision.

Up to four buyers may go together to purchase in the live auction and will be billed equally. After the Sale of Champions, the Sale Order will be assigned randomly.

Boosts will be accepted for live auction participants by completing a boost form. This form will be available in the sales office and at <a href="www.ccjrfairsales.com">www.ccjrfairsales.com</a>. Forms must be completed not later than 11:59 p.m. on Friday, August 7, 2022.

#### Online Auction:

The Online Auction provides any & all buyers the opportunity to place money on a 4-H or FFA member's project. This auction format replaces the Multiple Buyer Forms from past years. Buyers will be able to register Online up to the close of sale on August 7.

#### **Purchaser Sale Terms and Conditions:**

### 1. Bidding:

- a. You must have a Buyer's Number to purchase.
- b. Highest Bidder (s) of unit will pay the premium bid with the exhibitor/seller receiving the resale value from the packer bid unless custom processed.
- c. Custom Processing arrangements will need to be made with the exhibitor prior to the exhibitor weighing in their animals. Buyers will need to be registered and provide the exhibitor their buyer number and contact information. Please do this prior to July 22, 2022, since exhibitors/sellers must declare custom processing at weigh-in.
- d. Copey's Butcher Shop is currently the only custom processing choice for the Clark County Jr. Fair Auction. Buyers that have made arrangements with an exhibitor/seller for a custom processed animal, will also need to contact the custom processor to provide cutting instructions. Copey's Butcher Shop - 937-849-1338
- e. The buyer who receives the meat is responsible for the market value of the animal as well as their premium bid.

### 2. Terms:

- a. All purchases must be paid in full by 30 days after the sale. After 30 days, a 2% late fee will be added for each month the purchases are not paid in full.
- b. Checks payable to: Clark County Jr. Livestock Auction
- c. We accept Visa, Mastercard, Discover and American Express for payment. A 3% buyer premium will be waived for those who pay with cash or check.
- d. Buyers with outstanding invoices will not be provided a buyer number until outstanding balances are paid.
- e. There is NO BACK TO FARM option through the sale. Animals sold through any of the auctions are not to be returned to the exhibitor or any buyer, as those animals are not eligible to be shown by that exhibitor or any other 4-H/FFA member in any Junior Show including but not limited to any Ohio County, Independent, or State Fair.
- 3. **Purchaser's Obligation**: The above terms of sale shall constitute a contract between the buyers and seller and shall be equally binding upon both.
- 4. **Participate at Your Own Risk**: All persons attending the Auction do so at their own risk. The owners or anyone connected with the management of the sales assume no liability, legal or otherwise for any accidents that occur.

- 5. **Purchasers of Champions**: The Ohio Department of Agriculture requires that the Champion and Reserve Champion market beef, market dairy steer, market lamb, market hog and market goat go to harvest. Overall and Scramble Champions and Overall Reserve Champions (market beef, market dairy steer, lamb, hog, and goat) will be sent to Copey's Butcher Shop.
- 6. **Photographs of Champions**: Photographs of champions will be taken in the auction ring and used in buyer recognition and auction promotion.
- 7. **Exhibitor Re-Buys Not Allowed**: Junior Fair Livestock sold are not eligible to be shown or sold at any fair. There is not a back to farm option for animals sold through the Clark County Junior Fair Livestock Auctions.

**All accounts**: All Junior Fair Auction Accounts are subject to the above terms and conditions unless special arrangements for payment have been made with the Sales Management.

## Junior Fair Livestock Buyers will receive the following benefits if paid by October 1, 2022

- 1. A Listing in the Clark County Fair Book
- 2. Buyers who spend \$150 or more will receive recognition via the Maine's Board and Buyer Placard, Coupon for Pork Chop or Ribeye and Admission for Thursday or Friday of the 2023 Fair.
